Mr. Velella also asked if they would provide a list of costs for needed improvements.


Ms. Gorman said that John Molle, the Treasurer, would be able to provide this.

Executive Director May 12th Report to Council, 2014

Administration:

- Bob Butville of Suplee & Clooney audited the 2013 books. He found everything to be in order and even complimented us on how organized we were.
- Councilman Phil Vella working with BID on the 90 Main street project. A creative place-making space for a affordable pop up market concept. We met with Allison our intern and local resident Jeff Hersch as well as Warren from Mediatech to strategize the use.
- Currently using 90 Main as a showcase to fill empty windows and make them look inviting in conjunction with Councilman Phil Vellela. This will be the next topic for the Morning Brew Series. The car show will be featured this month of May.
- Strategic Committee: Review BID Goals to see where we are and what still needs to be done.
 Will create a performance management and performance budget to implement the goals. Mayor Erica indicated she would have the Council provide us with their goals that they would like to see implemented.

Public Comments -- Session I (up to approximately 3 minutes each, for a maximum of approximately 30 minutes)

Robert Schwade, 12 Park Avenue - expressed his frustration with the way the Borough yard sale was handled this year. Mr. Schwade urged Council to pick a date and stick with it each year. Mr. Schwade also suggested advertising with large employers, such as the hospital, in the future.

Council Vice President Velella informed Council had dropped the ball this year, and had not advertised properly.

It was determined that a date would be set at the January Reorganization meeting for the next year.

Council agreed there is a need to better advertise, and also include events such as this in a calendar that is available to the public.

Alan Brewer, 1 Coppermine Village - said he would like to know the results of Borough events in regard to revenue stream.

Sharon Ransavage, 4 Walter Foran Blvd. - informed of a recent accident involving pedestrians at the corner of Walter Foran Blvd. and Main St. Ms. Ransavage said she crosses this intersection twice daily on her walks, stating it is a very dangerous area.

Mr. Velella said he would like a traffic audit done, suggesting the timing of the walk sign could be adjusted.

Mayor Edwards said a study by the Borough Traffic Engineer would be done.

Chris Englehart, 180 Main Street - suggested making the corner a no right on red.

Mr. Velella said this could be a possibility.

Lois Stewart, 26 Spring Street - asked which streets were included in Resolution 2014-92.

Mr. Velella read the list from the Resolution.

Mayor's Report (up to approximately 3 minutes)

Mayor Edwards was pleased to announce she had been notified by the Governor's office that Flemington had been awarded an NJDOT local aid grant of \$170,000 for the Capner and Allen Streets project.

Concerning the resolution on the night's agenda announcing the members of the Borough's new Creative Team, Ms. Edwards informed more members would be added soon. Ms. Edwards said the team would be holding their first meeting in advance of the June 9th Council meeting. Ms. Edwards said she is very excited about this endeavor.

Ms. Edwards said she has been approached by the public concerning dates for the summer's Music on Main Street series. Ms. Edwards informed that, due to a conflict with the County Tricentennial concert series, Music on Main will be held Wednesday evenings this year, but will return to Thursdays moving forward. Ms. Edwards gave the following dates:

July 9th, July 23rd, August 6th and August 20th

Ms. Edwards said plans are to present the 2014 budget at the May 28th Council meeting, noting this is a Wednesday, as the regular Monday meeting would fall on Memorial Day. Ms. Edwards said there will be an additional workshop scheduled before the budget is presented, suggesting it be held at Borough Hall on at 6:00pm, on Tuesday, May 20th. Ms. Edwards asked Council to let her know their availability.

Ms. Edwards wished to congratulate the Samuel Fleming House Trustees on their impressive effort, noting she is very excited about the energy level of this new board.

Ms. Edwards wished to thank the Center for Educational Advancement for inviting her to their CORE Values business lunch. Ms. Edwards said it was a really nice afternoon.

Council Members' Reports (up to approximately 3 minutes each) Councilwoman Fine

Councilwoman Fine informed that, in advance of launching the new Borough Creative Team, she had met with the group Flemington Rocks and other artists concerning murals.

Concerning the Shade Tree Commission, Ms. Fine informed 2 trees had been planted as part of the Adopt-a-Tree program. Ms. Fine noted the tree in front of the library will be relocated. There are also plans to fix some brickwork on Main Street. Ms. Fine said Rutgers Nursery is contributing 2 trees to the Borough in commemoration of the Tricentennial - a Cyprus and Weeping Cherry.

Ms. Fine informed Financial Resources will be holding a shred day on May 15th.

Ms. Fine informed the Environmental Commission is on schedule for the June 8th deadline to submit for recertification with Sustainable Jersey.

Ms. Fine informed a Chairperson is needed for the Green Team.

Council members then had a brief discussion concerning the idea to paint murals on Borough buildings.

Councilman Gorman

Councilman Gorman informed work had begun on the Williams St/Spring St/Maple Ave project, adding bids for road work are being reviewed.

Mr. Gorman said work is being done to procure grants for the upcoming work on Capner and Allen Streets.

Mr. Gorman informed he met with the Borough engineer and DPW to review all roads in town, noting some are in bad shape. Mr. Gorman said he would present their recommendations at a future meeting.

Mr. Gorman informed he had attended a meeting with the residents of Walters Lane concerning work to be done on their block. Mr. Gorman said a meeting with the residents of Stangl Road would be held this week for the same reason.

Councilman Greiner

Councilman Greiner informed the Planning Board had discussed the streetscape plan, created by Tim DeLorm, of TerraNoble, at their April 29th meeting, noting there was widespread support of his ideas. Mr. Greiner said a different developer had attended each of the last two meetings, both indicating they want to see that a town has its act together, with boards that are in agreement with each other. Mr. Greiner asked Council to have a similar discussion to get their sense of the TerraNoble plan. In the meantime, Mr. Greiner said the Planning Board would be looking at financial options to align the TerraNoble plan and other projects with the master plan.

Mr. Greiner informed he had attended the May 10th Historic event at Washington Crossing, where the Borough HPC shared a booth with the Samuel Fleming House.

Mr. Greiner informed there is a need for sponsors and volunteers for the October 25th House Tour, which is the Borough's official event for the County Tricentennial.

Mr. Greiner said he had attended the May 9th transportation planning meeting. This was the second meeting, with discussion concerning better use of public transportation.

Councilman Novick

Councilman Novick informed that on June 14th, a FBID sponsored Flag Day concert would be held at the pavilion.

Mr. Novick said he is looking forward to the upcoming Samuel Fleming House outdoor shows, noting all performers donate their time.

Council President Swingle

Council President Swingle informed he had been made aware of significant flooding on Brown Street during the most recent rainstorm. Mr. Swingle said this matter would be addressed.

Mr. Swingle informed that, due to the recent warm weather, the Police Department had restarted bike and foot patrols.

Mr. Swingle informed he had attended the recent school board meeting to challenge the issue involving payment of health benefits to teaching assistants. Mr. Swingle said the discussion was one sided and he did not get to voice his concerns. Mr. Swingle said he is very disappointed that the budget was then passed without any dialog being allowed.

Mr. Swingle said he is working with Councilman Greiner on ways to lower the budget numbers.

Council Vice President Velella

Council Vice President Velella informed the Williams Street project should be complete by late July.

Mr. Velella said he met with the FBID board concerning banners across Main Street. Mr. Velella said the Borough offered the use of the DPW to hang the banners. Mr. Velella noted this plan would be revisited if it does not work out.

Mr. Velella informed he had met with the Union Hotel group informing they are working on their proposal.

Mr. Velella said he spoke with Borough Tax Assessor Kerwin concerning the Capner Street property. Mr. Velella said they are looking at all options for the parcel.

Public Hearing

Elaine Gorman, 34 New York Avenue - voiced her concerns with the new process of banner approval, and also with the provision that non-profit organizations will now be excluded from the banner program. Ms. Gorman also said she does not approve of the FBID charging an application fee.

Council President Swingle said he also disagrees with the possible exclusion of non-profit organizations. Mr. Swingle stated banners should not be limited to only those bringing economic benefit to the Borough but should also include those which bring general benefit to the health and wellbeing of its residents.

Councilman Greiner gave an explanation of the new banner approval process, explaining it is not as complicated as Ms. Gorman believes. Mr. Greiner also stated banners should advertise events that will bring business to town.

Borough Attorney Goodman stated this is a policy decision.

Mayor Edwards said she believes the previous banner approval procedure was much more streamlined than it is now.

Council Vice President Velella informed the FBID had purchased and installed the new banner hanging mechanism, so a small application fee is acceptable in order to supplement the cost. Mr. Velella said a non-profit can request the fee be waived at application.

Mayor Edwards said she agrees with Mr. Swingle, stating the ordinance needs to be more expansive to include events that are for the greater good of Borough residents.

Councilman Novick suggested changing the text to read "community benefit". Mr. Novick asked if another reading of the ordinance would then be needed if changes are made.

Mr. Goodman said yes.

Lois Stewart, 26 Spring Steet - asked who will be excluded in the new ordinance.

Mr. Greiner listed religious, political, single-business and single-charity groups among those excluded, because they are not primarily for the general economic benefit of Flemington.

Ms. Stewart said she believes groups promoting the health and general wellbeing of residents should be allowed to hang banners. Ms. Stewart also suggested banners should be limited to a shorter time period than the current 14 days.

Mr. Greiner said the intent of the ordinance change is to regulate content and limit the number of banner applications, as there are more requests than can be accommodated.

Mayor Edwards said she thinks there is an overuse of the banner program.

Alan Brewer, 1 Coppermine Village - said he believes it is a freedom of speech issue, noting he does not feel non-profit groups should be excluded.

Chris Englehart, 180 Main Street - said she is confused by the banner application process.

Both Mr. Greiner and Mr. Velella tried to explain it to her.

Councilman Gorman said he agrees with Ms. Stewart concerning how long a banner should be hung.

Elaine Gorman, 34 New York Avenue - suggested Council table the ordinance for further discussion.

Mayor Edwards suggested the Ordinance be tabled for further discussion.

Councilman Gorman said the original procedure was not broken, and now with the FBID involved he can see some issues arising, such as first priority going to a business on their "team". Mr. Gorman said he believes more work needs to be done to make the intent of the ordinance clearer.

Borough Attorney Goodman informed this ordinance does not deal with the FBID role in the process. Mr. Goodman said that issue is separate and needs to be dealt with on its own.

Mr. Gorman said he has concerns with the DPW now having the task of hanging the banners.

Councilman Novick suggested a motion to amend the wording in the ordinance be done this evening.

Mr. Swingle said he would be willing to work with Mr. Greiner on new wording.

Mr. Greiner said he has concerns, from a legal perspective, with not having a final ordinance on the books at this time.

Mr. Goodman informed there are presently no guidelines which show the intent to limit types of banners allowed.

Mr. Greiner moved to table the ordinance.

Mr. Goodman informed the ordinance would have to be a presented again as a first reading only if changes are made, otherwise the current public comments would stand.

Roseanna DeMarzio, The Grill Shack - was present to speak about an issue she had with a Borough employee. Ms. DeMarzio said Lambert Smith, of Property Maintenance, entered her restaurant and proceeded to speak with her in a loud and aggressive manner. Ms. DeMarzio also stated that Mr. Smith did not identify himself as a Borough employee. Ms. DeMarzio said she felt threatened, noting she had never been treated in this manner at her other restaurant in Hillsborough. Ms. DeMarzio said the matter was in relation to a trash issue, which she said she would fix.

Mr. Greiner said Ms DeMarzio did not need to justify why the conduct she described was unacceptable and that he would investigate the matter.

Mayor Edwards apologized to Ms. DeMarzio and said she would be in touch with her concerning the matter.

Lois Stewart, 26 Spring Street - asked for the status of the no turn on red sign at the corner of East Main Street and Walter Foran Blvd.

Mayor Edwards informed Assemblywoman Simon was working on the matter.

Ms. Stewart asked about the status of the house on East Main Street that may be donated to the Borough.

Council Vice President Velella said he is looking into grants to aid in a clean up of the property.

Ms. Stewart asked about the status of the Mayors Roundtable.

Mayor Edwards informed it would not launch until June as she is looking to tweak the concept. Ms. Edwards said she is seeking ways to make it such that more people may participate. Ms. Edwards asked Council for their suggestions. Ms. Edwards also noted it is important to ensure confidential discussion when necessary. Ms. Edwards said she would prefer the meetings to be more like an open house, with a wider span of time. Ms. Edwards again explained how these meetings would reinforce the work of the FBID, while offering more opportunities for business owners to meet with each other and also speak with the Mayor and members of Council.

Councilman Gorman explained that the streets are being cleaned every night. Mr. Gorman also said 5 maple trees would need to be removed, but informed Mrs. Hunt's tree would stay. Mr. Gorman agreed to walk the block with Ms. Stewart to discuss the project and tree removal.

Ms. Stewart questioned the intention of the current Union Hotel developers concerning the expanded redevelopment area.

Mr. Velella said it is very disappointing to hear the many rumors circulating about the project.

Al Brewer, 1 Coppermine Village - said he thinks the Mayor's Roundtable idea is a very good concept.

Chris Englehart, 180 Main Street - asked about possibly moving the house at 54 East Main Street if the land cannot be cleaned up.

Mr. Velella said the house need quite a bit of work, which would make that plan too pricey.
